**WE HAVE ENHANCED EAS2 FOR MULTI TITLE/MULTI LOT REQUESTS AND
POSTCODE ENTRIES****A NOTICE TO CONVEYANCERS**

We have enhanced EAS2 (Electronic Advice of Sale) to better assist your online land requests.

Multi-lot and multi-title requests for contiguous properties can now be processed in a similar manner to the old EAS application, doing away with the need to submit a request for each title/lot. This means that conveyancers need create only one request to deal with multiple titles/lots, typical in farm property transactions, on the same Offer and Acceptance. (Refer to the example screen shown in **FIGURE 1 section 7**).

It's a feature of the old EAS that you told us you'd rather be retained and we thank you for helping us improve our services.

Related fees payable for these requests are shown below (refer to the example screen shown in **FIGURE 2 section 8**, demonstrating charges applicable):

1 EAS2 ADMINISTRATIVE FEES

One fee per request will be charged.

2 WATER CORPORATION FEES

For properties outside the metropolitan area, the Water Corporation will charge one fee per request.

For properties within the metropolitan area, the Water Corporation will charge one fee per property. This is to cover the independent water supply provided to each lot.

3 LOCAL GOVERNMENT FEES

Local governments can choose whether to charge a fee per lot or a fee per request. Please see [section 9](#) for charging methods.

4 DEPARTMENT OF TREASURY AND FINANCE FEES

The Department of Treasury and Finance fees will be applied per request.

5 PARTY WALLS

Party wall lots are excluded from fees, however all lot details should be included on your request.

6 INTERSTATE POSTCODES

EAS2 has been further modified to automatically populate interstate postcode fields. It will do this after you have entered a suburb and clicked onto 'next'.

A link to Australia Post is now available that allows postcodes to be checked and is located under 'useful links'.

EAS2 is an initiative of the Department of Land Information, the Water Corporation and the Department of Treasury and Finance.
